Esmail Khatib: Islamic Republic of Iran Minister of Intelligence

In August 2021, the Islamic Consultative Assembly ratified President Ebrahim Raisi's selection for Minister of Intelligence and Security, Esmail Khatib, a mid-ranking cleric who has attained the title of Hojjat ol-Eslam, which means "proof of Islam." Khatib has decades of experience in Iran's civilian intelligence apparatus, holding senior positions in the Ministry of Intelligence and Security (MOIS) and the Judiciary branch's counter-intelligence department. Khatib's revolutionary credentials date back to his seminary studies at Qom, where he studied under the disciples of the founder of the Islamic Republic, Ayatollah Ruhollah Khomeini. Ali Khamenei was among Khatib's teachers, and his appointment to the sensitive post of intelligence minister is indicative of their close relationship.

Early Career

Born in 1961, Khatib <u>began</u> his seminary studies in the holy city of Qom in 1975 or early 1976. An official government account <u>states</u> that he studied under Grand Ayatollah Mojtaba Tehrani, a senior cleric who supported Grand Ayatollah Ruhollah Khomeini. Current <u>Supreme Leader Ayatollah Ali Khamenei</u> led prayers during Tehrani's funeral in the 2010s, demonstrating that Khamenei held Tehrani in high regard. At some point, Khatib also studied under Khamenei, but it's not immediately clear when.

Following the 1979 Revolution, Khatib engaged in propaganda activities, and enlisted in the <u>Islamic Revolutionary Guard Corps (IRGC)</u> at the outbreak of the Iran-Iraq War in 1980. According to a parliamentary report, he joined the IRGC intelligence and operations unit at the behest of founder Hassan Baqeri. He <u>sustained</u> a severe injury in combat that ended his deployment to the front. Khatib's brother and brother-in-law were also killed in combat.

In 1985 or early 1986, Khatib joined MOIS, which was established in 1983 and was the premier intelligence service at the time. Parliamentarian Mohsen Zanganeh <u>credited</u> Khatib with overseeing the investigation and prosecution of Mehdi Hashemi, commander of the IRGC Office of Liberation Movement, who was convicted and put to death on charges related to treason in 1987. Hashemi was related through marriage to Ayatollah Hossein-Ali Montazeri, the designated successor of Khomeini. Hashemi's conviction led to Montazeri's ultimate removal from consideration for the post. As scholar Ali Alfoneh has <u>documented</u> in his book "Political Succession in the Islamic Republic," the networks of then-President and future Supreme Leader Ali Khamenei, then-Parliament Speaker Akbar Rafsanjani, and Hassan Khomeini, the founder's son, were behind Montazeri's removal. Another investigator in the notorious Hashemi case, <u>Qolam-Hossein Mohseni-Ejei</u>, is the current Judiciary chief. Khatib also appears to have served in the foreign directorate section in various capacities, for instance, as an analyst.

Senior Intelligence Posts



Khatib served as the director of the Intelligence Ministry's Qom Province for more than a decade, beginning in the 1990s. This is a highly sensitive post, since religious seminaries in Qom fall under the jurisdiction. Although the Islamic Republic was founded by a cleric and many of its top posts are reserved for clerics, the state has had a contentious relationship with the clergy in the seminaries. One of the primary points of tension resulted from Khomeini placing the authority to represent the 12th Shiite Imam Mahdi, or Messiah – whom Shiites believe is in occultation until Judgement Day – within the hands of the Supreme Leader. Prior to that, clerics collectively exercised the authority to represent the Mahdi. In addition, after Khamenei came to power, many clerics did not accept him as a senior religious figure and, later, refused to acknowledge his Ayatollah status. Khatib's appointment to this position was an indication of Khamenei's trust.

Khatib's tenure as MOIS Qom Province director was a contentious subject during Parliament ratification debates. One of his detractors, who belongs to the hardline Steadfastness Front faction, <u>accused</u> Khatib of not doing enough to "predict and prevent" the "conspiracies" in Qom seminaries like "non-revolutionary and anti-Revolution" activities. One of his defenders stated that working in intelligence in Qom requires deftness, and credited Khatib and agents for preventing the success of "the Dominant System [West] and internal collaborators so that the anti-thesis of the revolution rises from Qom." That is a reference to clerics who, for example, support a greater degree of separation between religion and politics.

Khamenei's trust was further demonstrated when the Supreme Leader approved Khatib's appointment to the Office of Supreme Leader Protection <u>Organization</u> in 2010. That unit would be in charge of facility and personnel protection for Khamenei's inner circle. In 2012, then-Judiciary chief <u>Sadegh Amoli Larijani appointed</u> Khatib as director of the Judiciary branch Intelligence Protection Center, one of the intelligence agencies in the Islamic Republic <u>theoretically</u> overseeing Judiciary personnel. However, some critics have <u>pointed</u> out that the intelligence unit was formed without "approval in the Islamic Consultative assembly and outside the authority of the Judiciary branch," and that it interferes with the duties of the Intelligence Ministry.

Khatib's tenure in the Judiciary intelligence unit was also the subject of criticism in the Parliament. Critics charged him with failing to do enough regarding prominent corruption cases like that of Akbar Tabari, deputy to former Judiciary branch chief Ayatollah Sadegh Amoli Larijani. After Raisi was selected as Judiciary branch chief in 2019, he <u>led</u> the prosecution of Tabari on corruption charges.

Khatib was appointed Minister of Intelligence and Security in August 2021 under <u>President Ebrahim Raisi</u>'s administration. However, appointment to the intelligence ministry post and the ministry's priorities is a negotiation, at best, between the <u>Presidency</u> and the <u>Office of the Supreme Leader</u>.



A significant difference between Khatib and his predecessor Mahmoud Alavi is that Khatib has actual experience in the ministry. Alavi admitted that he had no intelligence experience when former President Rouhani sought to appoint him. Khatib comes in with the most hands-on experience compared to all past intelligence ministers. In addition to the above-mentioned intelligence roles, Khatib formerly served as head of security at Astan Quds Razavi, a wealthy endowment in charge of the Imam Reza shrine in Mashhad.

Khatib's tenure as Minister of Intelligence and Security comes amid questions swirling significant intelligence failures in recent years, namely the <u>assassination</u> of military commander and nuclear scientist Mohsen Fakhrizadeh and sabotages against nuclear facilities, acts carried out by Israel, which led to a <u>blame game</u> between MOIS and the IRGC.

On September 9, 2022, the U.S. Treasury Department <u>designated</u> Khatib pursuant to <u>Executive Order (E.O.) 13694</u>, a presidential mandate that expressly authorizes the U.S. government to sanction individuals engaging in malicious cyber activities. Under Khatib's leadership, the Treasury Department determined that "the MOIS directs several networks of cyber threat actors involved in cyber espionage and ransomware attacks in support of Iran's political goals." The press release also stated that the Iran-sponsored threat actors have engaged in attacks against the U.S. government, private sector organizations, and critical infrastructure. The MOIS was also, at the same time, designated under E.O. 13694.

The catalyst for these sanctions appeared to be multiple rounds of Iran-sponsored <u>cyberattacks</u> against Albania, including against the government's computer systems. However, the MOIS's involvement in malign cyber operations has long been on the U.S. government's radar. In September 2020, APT39—another entity owned or controlled by MOIS—was <u>designated</u> under E.O. 13553.

In addition to these sanctions, the U.S. government announced another round of sanctions against Khatib on September 22, 2022. Alongside Iran's Morality Police and its senior leaders, Khatib was <u>added</u> to the Treasury's list of individuals designated under <u>E.O. 13553</u>, which targets human rights offenders. (The MOIS was already designated under this authority in February 2012). The human rights designations were a response to the death of Mahsa Amini, a 22-year-old Iranian woman in the Morality Police's custody for improper hijab when she was beaten into a coma. She is mentioned in the opening paragraphs of the Treasury's press release.

As the Minister of Intelligence, Khatib also fulfills propaganda aims. He disseminates the view that the protests in Iran are the result of enemy infiltration. This narrative likely does not pacify the anti-regime movement because participants in the movement do not view the West as the enemy. The protesters view their rulers as the chief obstacle to a better life. In response, Khatib has <u>framed</u> those opposed to the regime's conspiratorial narratives as agents of the West,



particularly the U.S. To the extent his statements sway popular opinion in Iran, this narrative pits staunchly anti-Western regime supporters against proponents of secular democracy. It also justifies a harsh crackdown against protesters, because they can be charged with committing treason in seeking to overthrow the revolutionary government.

Khatib has also blamed Saudi Arabia for the unrest, <u>saying</u> in November 2022 that Iran's "strategic patience" was running out and that it may decide to retaliate against Saudi Arabia for its support for the protest movement. Khatib's complaint was elucidated in an interview published on Tasnim news, where he <u>said</u> that Saudi Arabia provides the "expenditures" for the anti-regime movement and backs "the London-Saudi-American [media] trio (BBC Persian, Saudi International, and Manoto)." Iran has long harbored suspicions of Saudi news media, including the London-based Iran International, a major source of news programming for anti-regime protesters in Iran, which allegedly receives Saudi funding. According to some <u>reports</u>, Saudi Arabia might reduce content critical of the regime as part of the March 2023 Chinese-brokered normalization of diplomatic ties between Iran and Saudi Arabia. Yet, no indication exists that Iran International has changed its journalistic practices.

Finally, Khatib has regularly accused Israel of running intelligence operations in the country to undermine the regime. In May 2023, Khatib <u>said</u> that an Israeli-linked "terrorist group" had been apprehended near the western borders of Iran, though the circumstances were not immediately clear. The arrests were nothing new, as the MOIS regularly targets Kurdish opposition groups near the border with Iraq. In particular, in July 2022, Khatib <u>singled out</u> the Komala Party as "a mercenary of the Zionist regime."

What We Can Expect From Khatib

Khatib detailed his top four priorities as Minister of Intelligence in briefing the National Security and Foreign Policy Committee. He <u>pledged</u> to "intelligently confront" the "main partners and movements of economic, social, culture, etc. corruption." Accordingly, under Khatib's leadership, the MOIS has increased its violence against activists, journalists, and members of religious minority communities. Secondly, Khatib proposed to make "maximum use of revolutionary forces in the ministry with priority of revolutionary and *hezbollahi* [phrase for Islamic Republic supporters];" to "strengthen and activate hidden diplomacy for effective intelligence exchange, increase the system's strategic depth and influence with allied countries inside and outside the region, and support Islamic movements, Hezbollah, and cooperate with the Islamic Revolution Guard Corps Quds Force to strengthen the Resistance Front." He also vowed to confront "the infiltrating movement in the government especially the country's sensitive and vital centers and sites."

In his speech in the Parliament, Khatib <u>called</u> for "transformation in the hidden intelligence formations" and for the ministry to "produce intelligence and oversight in providing security



and awareness in monitoring all aspects of complex and various security layers at the national, regional, and global levels." In recent years, the ministry has been weakened compared to the IRGC Intelligence Organization (IRGC-IO). Overlapping responsibilities between MOIS and IRGC-IO have led to <u>clashes</u> that have spilled into the public. For example, MOIS disagreed with IRGC-IO when it arrested several environmentalists on espionage charges.

Khatib has cultivated deeper trust in Khamenei and his office, which have a symbiotic relationship with the IRGC. It remains unclear how Khatib would navigate the <u>power struggle</u> between the Islamic Republic's competing intelligence organizations, but it would be hard to imagine the IRGC-IO losing ground anytime soon. In theory, Khatib could try to reduce friction between MOIS and IRGC-IO to increase efficiency in the face of external and internal threats, but overlapping responsibility inevitably leads to some fighting.

At a meeting convened by the Supreme Leader on June 16, 2023, several top-ranking military and intelligence officials gathered to discuss the interagency competition, hoping to reduce friction. Khatib <u>called</u> for joint strategies and information sharing between his ministry and the IRGC-IO. The MOIS's mandate—in short, to preserve and protect the Islamic Republic of Iran—also overlaps with the IRGC's hardline mission, so cooperation in some areas between the intelligence agencies is possible. The MOIS likely took on new responsibilities regarding Iran's regional proxy and partner network, particularly after <u>Qassem Soleimani's</u> death in January 2020, though this is generally the IRGC's purview. While the IRGC's Quds Force takes the lead in building up its proxy and partner's military capabilities, especially in <u>Iraq</u> and <u>Syria</u>, the MOIS may take on a supportive role.

In late August 2023, Khatib <u>addressed</u> the 24th assembly of senior IRGC officers in Tehran, where he praised Iran's multiple intelligence agencies for their collective efforts in thwarting "enemy conspiracies" and addressing domestic threats.

Khatib stated that Iran's secret services <u>are currently</u> holding "spies from Sweden, France, and Britain," referring to certain Western hostages. Without providing specific names or details about the detainees, the intelligence minister even claimed that some of these "spies have been executed" despite foreign pressures. His remarks came after the Islamic Republic <u>executed</u> British-Iranian national Alireza Akbari, a former Iranian deputy defense minister, who was sentenced to death in January 2023 on charges of spying for Britain. Similarly, in May 2023, Iranian-Swedish political activist and former leader of the Arab Struggle Movement for the Liberation of Ahwaz (ASMLA), Habib Chaab (Asyud), <u>was also executed</u>.

Khatib <u>emphasized</u> the regime's ideological belief that "the enemy" continues to plot against the Islamic Republic, which, he claimed, has risen to the status of a "global power." He asserted that "50 intelligence services" worldwide have established "Iran desks" to confront this "new



global power." He reiterated that "the enemy's" goal is to destabilize Iran and decrease participation in the March 2024 parliamentary elections.

On October 22, 2023, fifteen days after Hamas's brutal terrorist attack against Israel, Khatib, speaking to the Tehran Times, issued a dire warning: "The supports should await the divine revenge that will be imposed on them by the hands of people." Khatib emphasized that this revenge would be "harsh, destructive, deadly, and destructive."

During a meeting of the administrative council of Lorestan Province in Khorramabad, Khatib condemned what he described as the mass killing and genocide perpetrated by Israel in Gaza. He accused Israel of committing war crimes "in front of all the claimants of human rights."

"This catastrophic act will be engraved in history as the betrayal toward humanity, and these war crimes will result in the irreversible defeat of the normalization process," Khatib asserted. He also argued that the efforts of certain governments to win favor with the U.S. in the region would ultimately prove fruitless, as "the equation has changed."

Khatib praised the Al-Aqsa Storm operation as "the most complex, intelligent, brave, and effective operation of the resistance front," describing it as "deadly, irreparable for the Zionist regime" and predicting that it would cause "a serious strategic change in the regional and global equations."

Khatib claimed that "Tel Aviv will never enjoy security," citing what he described as worsening social and political fractures both within and outside Israel. "The trust, hope, deterrent power, and the security of the occupiers will be taken away," he said, adding that the Al-Aqsa Storm operation demonstrated that "powers, equipment, and technologies cannot be a source of security for those who have started atrocities."

Khatib also held the U.S. responsible for the bloodshed in the Gaza Strip, citing its support for Israel and pointing to President Biden's visit to Tel Aviv and his unwavering backing of Israel. "The massacre of defenseless Palestinians," he stated, "showed that human rights are a tool in the hands of the superpowers to pursue their cruel goals." Khatib criticized the United Nations Security Council, saying, "The Security Council has not done anything to support the oppressed."

In November 2023, Khatib <u>ridiculed</u> U.S. Secretary of State Antony Blinken, accusing him of "moving around the region like a peddler" in search of a solution favorable to Israel. Khatib claimed that Blinken, with the support of certain countries, was actively pursuing what he called a "dignified ceasefire" in the ongoing conflict between Hamas and Israel.



Khatib previously stated that "a regime, initially claiming victory in the region following operations against Hamas, is now shifting its focus towards negotiating a ceasefire." He suggested that this ceasefire was being sought in exchange for the release of prisoners and as part of an effort to weaken Hamas's control over Gaza.

The Minister of Intelligence argued that the October 7 attack by Hamas was a setback for the United States in the region. He claimed that "the U.S. dominance, previously asserting military, intelligence, economic, and political support for the Zionist regime, has collapsed."

Following the sudden death of former Iranian President <u>Ayatollah Ebrahim Raisi</u> in May 2024, caused by a helicopter crash in the mountainous northwest region of Iran that also claimed the lives of the regime's foreign minister and other officials, <u>Masoud Pezeshkian</u> was selected as Raisi's replacement. Days after his inauguration, the new president announced that he would <u>retain</u> Khatib as the head of the regime's Ministry of Intelligence.

After the assassination of top Hamas leader <u>Ismail Haniyeh</u> in a guesthouse in Tehran in late July 2024, where he was staying for the inauguration of Pezeshkian, Khatib told Fars News Agency that the assassination <u>was carried out by Israel and approved by the United States.</u>

Just days before Haniyeh's death, the Students News Network (SNN) asked Khatib about the operations carried out by the Ministry of Intelligence in the Islamic Republic of Iran that he was most proud of. Khatib responded that the ministry's most significant achievement during his tenure was dismantling "Mossad's infiltration network." Khatib also stated that Haniyeh's assassination proves that the "Al-Aqsa Flood"—Hamas's name for its deadly rampage through southern Israeli communities on October 7, 2023—was a success, though he did not provide further explanation. The Minister of Intelligence extended his condolences to the Palestinian people, the Iranian "resistance," including Hamas, Iranian Supreme Leader Ali Khamenei, Haniyeh's family, and "all freedom-loving people worldwide." Haniyeh's death was the result of a major intelligence failure by the Iranian regime, with all the visible indicators revealing that foreign security services have managed to infiltrate the highest levels of the Islamic Republic's security-intelligence apparatus. Against the backdrop of successive intelligence failures, the fact that Khatib managed to retain his position as Minister of Intelligence in Pezeshkian's administration came as a surprise to many.

Khatib will continue to be a force in the Pezeshkian administration and will seek to shield the Ministry of Intelligence from any fallout from Haniyeh's killing in Tehran. This is because the IRGC's Intelligence Organization and other entities will be blamed, which fall outside of Khatib's authority. The Haniyeh assassination, however, will trigger a new wave of <u>purges</u> across all security-intelligence agencies in the Islamic Republic. Under Pezeshkian, Khatib will be one of the main forces spearheading this purge across the Ministry of Intelligence, with the objective of rooting out foreign spies from MOIS. These efforts will likely be coupled with an increase in



ideological indoctrination for all members of MOIS, not least among its higher ranks, to ensure absolute ideological compliance – a mechanism Khamenei has used, alongside purges, to guarantee loyalty to his rule. Pezeshkian will find it difficult to implement his campaign promises with Khatib in his post, as he was the intelligence minister during the brutal suppression of the Woman, Life, Freedom protests in 2022-23. The fact that Pezeshkian was forced to keep Khatib in his position—unlike his predecessors who were able to nominate new intelligence ministers upon taking office—is evidence of how constrained he will be as president.
